Agenda Item: 8a-Friends of Urbanna

Background: Meetings with this group concerning essay contest, open house, funding, and other matters have turned up an undocumented understanding that The Friends of Urbanna serve in an advisory role to the council pertaining to the historic Scottish Factor Store serving as the Urbanna Museum and Visitor Center. All parties desire formalizing this understanding with a Memorandum of Understanding (MOU).

Following is some language that can be used that was provided by the Friends of Urbanna as well as some questions that can be addressed in the document.

Fiscal Impact: Unknown, but some staff time.

Staff Recommendation: As documentation is crucial to long-term understanding of relationships, commitment, and authority, such a document should be created to establish the role of The Friends of Urbanna as advisors to the council pertaining to the historic Scottish Factor Store serving as the Urbanna Museum and Visitor Center. This document should include a regular reporting schedule (quarterly has been discussed) as well as a funding commitment involving dedication of the cigarette tax and Museums of Middlesex contributions which has been the practice.

Council Action Requested: Direct staff to develop a MOU as noted above.

Sample Motion(s): Not at this time, but such a motion to adopt the resulting MOU will be provided once completed.

The Friends of Urbanna Museum is a 501c3 organization that exists to work with the Town of Urbanna to assist in the enhancement and preservation of the Urbanna Scottish Factor Store Museum and Visitors Center properties, grounds and contents owned or on loan. The goal of the organization is to attract residents and visitors to learn about the history of Urbanna and the surrounding area; the Scottish Factor Store Museum (a unique structure and the last one remaining) and the Mitchell Map housed in the Museum. All of the activities of the Friends of Urbanna are intended to foster continued use and enjoyment of these one-of-a-kind town assets.

The Town Council of Urbanna, recognizes the need for assistance in the ongoing preservation of the Scottish Factor Store and guidance in the identification of the necessary actions to preserve and enhance this unique building and its contents. To this end, the Town Council of Urbanna is appointing Friends of Urbanna as their advisors on these matters.

Questions:

- How do we indicate this to be an ongoing appointment that is not reviewed or reappointed with each change of the Council membership?
- This to be a resolution to support the previous appointment that cannot be found in town records, correct?



Agenda Item: 8b-Virginia Street Terminus

Background: Inquiry was received as to what are the limitations on use of the above referenced property for public access to launch kayaks and park vehicles. Investigation has found a 20-foot-wide easement exits for emergency vehicle access in the parcel which is approximately .1 acre in size (30-foot x 150 foot (avg)). As no one can predict the need for this access, it should be unobstructed at all times. Depicted on the attached portion of the plat used to convey, the easement is not delineated exclusively in the center or to one side. The property is also the site to one of the Museum in the Streets markers, but that is the only signage associated with the property and it speaks to historical, not present use.

Fiscal Impact: Sign Production and staff time.

Staff Recommendation: Given the limited amount of space that could be obstructed; a 10 feet wide strip along northern most property line at most, tidal inundation, the proximity of a privately owned fence as well as the museum in the streets sign, parking is not advisable at this location. Staff recommends signage be employed that permits kayak/canoe drop off and launch at your own risk, but no parking. The at-risk language is recommended because of the potential presence of residue commercial building parts on the property and along the water's edge and

Council Action Requested: Consider directing staff to develop, procure, place signage to address the initial inquiry.

Agenda Item: 8d-Updated Pool Rules

Background: Council established rules for the Marshall Community Pool at Taber Park. Finalized construction of the new pool, insurance consultation, and review by Signature Pools Management, LLC have resulted in the need to revise those rules. The most notable are the prohibitions on diving (exempting sanctioned competitive diving) for the entirety of the pool as well as vaping. There is additional language concerning guardian proximity to non-swimmers under six or using floatation devices.

Fiscal Impact: Production of signage which would be incurred regardless of verbiage.

Staff Recommendation: Consider and advise.

Council Action Requested: None at this time.

DRAFT Pool Rules

Failure to adhere to the following rules subject the offender to removal, banning, and/or law enforcement action.

- All patrons and their guardians accept use of the pool at their own risk.
- Hours: Noon to 6 pm Tuesday through Saturday. 1 pm to 6 pm Sunday.
 Closed Mondays except Memorial Day and Labor Day.
 Pool may be closed at the discretion of on-site management due to weather, staffing, or other issues. Patrons will comply as directed.
- Shower before entering the pool.
- No Diving. Sanctioned competitive events are exempted.
- No horseplay.
- No glass containers allowed.
- No spitting or clearing of nose/sinuses in the pool or deck.
- No tobacco use of any kind, vaping, or consumption of alcoholic beverages is allowed.
- No bikes, skateboards, or roller blades permitted in the pool or deck area.
- No pets permitted in the pool or deck area; licensed /credentialed assist animals may be exempted on a case-by-case basis, but those animals will not be allowed in the pool.
- Admission may be refused to anyone with skin abrasions, colds, coughs, inflamed eyes, infections or wearing bandages.
- All infants and toddlers who are not potty trained must wear a swim diaper in the pools.
- Non-swimmer under the age of six, or children using floatation devices need to be within arm's reach of their guardian.
- All children ages 8 through 13 will be permitted within the pool area unaccompanied if they have passed the basic swimming test. Otherwise, they must be accompanied by an adult.

The basic swimming test consists of:

- Swim 2 lengths of the pool using any stroke and not stopping or touching the bottom
- Float for 1 minute
- Tread water for 1 minute
