

DESIGN AND AMENITIES



A fter more than two years of identifying and modifying plans to fit community needs and budget constraints, we have plans to build our new Taber Park Pool with the following amenities: 6-Lane Competition Pool for swim meets and general enjoyment, Sun Shelf for shallow water recreation, and slide.

The new Pool House will include outdoor showers, male and female changing rooms, a snack shop, pump and equipment rooms, office. Two sides of the building are connected with a covered corridor with locking gates on front and back. The male and female restrooms will be accessed from that corridor and will also serve as public restrooms, year-round.





CONSTRUCTION PROCESS AND TIMELINES

Despite delays, we are told the pool could be ready for an opening on Memorial Day, or soon afterwards. As of February 16, we are still waiting for the architect's final drawings before final costs can be quoted and permits can be issued.

PROPOSED USER FEES

Participation for town and county residents will be crucial. We've devised a preliminary structure of user fees to be implemented once the pool is open. Tracking methods are still under discussion.

Town Residents

- Children 6 and under, accompanied by a paying adult are free. (Town resident or otherwise)
- Each town residence receives 3 free non-transferable 1-day family passes.
- Once those have been exhausted, a resident may pay \$5 for a day pass, or \$12 for a family day pass which admits up to 6 people at a time.
- Individual may purchase a season pass for \$100.
- Family may purchase a season pass for \$200.

County Residents

- Individual day pass for \$8, or a family day pass for \$25, which admits up to 6 people at a time.
- Individual season pass for \$200.
- Family season pass for \$400.

Swim Team Members:

- No charge for in-town swimmers.
- \$50 per swimmer out of town (for the season).

FUNDRAISING PLANS AND OPTIONS

Town Council has already raised more than \$800,000 to pay more than one half of the \$1.1 million expected cost.

We have devised various fundraising avenues, some being tax deductible, others offering a potential return on investment. Additionally, we plan to host 50/50 raffles and/or auctions to raise funds.

CHARTER MEMBERSHIPS - NOT TAX DEDUCTIBLE

These are offered during our fundraising campaign as a one-time large donation attached to a named residence. Those owning or occupying the "Charter Residence" will have free use of the pool for its viable and active life. (Please remember that our last pool was used for about 60 years). Charter Membership benefits will transfer with the sale or transference of the residence, giving the property value-added status when marketing it. Charter Memberships will provide a major boost of financial support, but will not be tax deductible. The purchaser of a Charter Membership will also receive an engraved brick for the walkway with his/her name and designation of "Charter Member." Although the benefits will be the same whether in town or outside of the town limits, there will be a cost differentiation because town residents are already supporting the pool through town taxes.
